

Citizenship/Identity Review July 2006-June 2007

Proof of Eligibility Section 205-2

As of July 1, 2006, individuals now must present documentary evidence to establish both identity and citizenship. All documents must be either originals or copies of originals certified by the issuing agency.

Current Medicaid recipients must meet the requirement at their first review after July 1, 2006. A reasonable opportunity to provide the information to satisfy the requirement must be given. Medicaid eligibility may be continued as long as a good faith effort is being made to obtain it. There are no specific time frames. Worker will need to set alerts and document the efforts being made to demonstrate the efforts that are being made if the information is not available at the time of review.
